\*A note about the Ecclesiastical Council: remember Brenda McCutcheon's council in December 3 years ago? These meetings are held to discern whether the person requesting ordination in the UCC is ready for the honor.

At the council, clergy and designated delegates from all the churches in the Susquehanna Association have the opportunity to ask the candidate questions, based upon their reading of the ordination paper.

A yea/nay vote is taken following the question and answer session, and then a date can be set for the ordination ceremony.

### MOM'S EMPTY CHAIR

The following account was sent to me by one of our members. Often, people want to talk with me about prayer. If you have questions about your prayer life, I offer this story as a possibility for you to try.

A woman's daughter had asked the local minister to come and pray with her mother.

When the minister arrived, he found the woman lying in bed with her head propped up on two pillows. An empty chair sat beside her bed.

The minister assumed that the woman had been informed of his visit. "I guess you were expecting me," he said.

"No, who are you?" said the mother. The minister told her his name and then said, "I saw the empty chair and I figured you knew I was going to show up."

"Oh yes, the chair," said the bedridden woman. "Would you mind closing the door?" Puzzled, the minister shut the door.

"I have never told anyone this, not even my daughter," said the woman. "But all of my life, I have never known how to pray. At church I used to hear the pastor talk about prayer, but it went right over my head.

"I abandoned any attempt at prayer," the old woman continued, "until one day four years ago, when my best friend said to me, 'Prayer is just a simple matter of having a conversation with Jesus. Here is what I suggest...

'...sit down in a chair. Place an empty chair in front of you, and in faith see Jesus on the chair. It's not spooky because he promised, "I will be with you always." Then just speak to him in the same way you're doing with me right now.'

"So, I tried it and I've liked it so much that I do it a couple of hours every day. I'm careful though. If my daughter saw me talking to an empty chair, she'd either have a nervous breakdown or send me off to the funny farm."

The minister was deeply moved by the story and encouraged the old woman to continue on the journey. Then he prayed with her,



anointed her with oil, and returned to the church.

Two nights later the daughter called to tell the minister that her mama had died that afternoon.

"Did she die in peace?" he asked.

"Yes, when I left the house about two o'clock, she called me over to her bedside, told me she loved me and kissed me on the cheek.

"When I got back from the store an hour later, I found her. But there was something strange about her death.

"Apparently, just before Mom died, she leaned over and rested her head on the chair beside the bed. What do you make of that?"

The minister wiped a tear from his eye and said, "I wish we could all go like that."

### Christian Education Committee Archives

As our church is actively focused on our children and youth programs at present, it was interesting to find this report in a 1975 Pioneer.

#### Christian Education Committee

The film on world hunger shown after the Bike-a-thon Walk-a-thon was obtained by the Christian Education Committee.

Vacation Bible School was directed by Marilyn Twentyman during the week of August 18. The curriculum, "Followers of Jesus," was described as excellent by the teachers and enjoyed by a steady attendance of 56 students. The offering received during the Vacation Bible School (\$45.25) was sent to Heifer Project to send 181 baby chicks to the Philippines.

The committee organized the family breakfast held for the opening of Sunday school in the fall. The Christian Leadership School held in Cortland was attended by all of our Sunday school teachers and funds were provided for their enrollment.

A Youth Fellowship for Junior and Senior Highs has been organized by Judy Riehlman and Elinor Currie.

The Diaconate questionnaire concerning study and sharing groups was discussed for adult education possibilities. The strongest responses were in the areas of Bible Study (Sunday school class), Bicentennial (youth fellowship), couples with growing children (weekly group meetings Thursdays, now), and sharing personal and family concerns.

#### **Question: What is Ordination?**



Briefly and essentially, ordination is the process by which individuals are consecrated (set aside) as clergy to perform

various sacraments and duties according to the design of the denomination which grants the designation.

Once an individual is in covenant with a local church and a Committee on Ministry (our CAM is part of the Susquehanna Association), basic qualifications are discerned:

- acknowledgement of Jesus Christ as the sole head of the church;
- membership in a local UCC church; and.
- demonstrated knowledge and affirmation of the history, polity, and practices of the UCC.

Discernment includes assessment of the candidate's educational path relative to the study of preaching and leadership, theology, congregational life, and pastoral care and counseling.

Being ordained in the UCC means that one can serve if called to any church body within the denomination. Without being ordained, an authorized pastor can fully serve a particular church and offer all the duties and sacraments to that church. A lay minister is able to serve a church but is not authorized to perform the sacraments. All of these categories are overseen by the Committee on Ministry.

My upcoming Ecclesiastical Council is part of the process leading to ordination, and is explained elsewhere in this Pioneer. Ordination is one of the central events in a pastor's life, and a significant experience that one recalls with awe and gratitude, because it speaks of a commitment to a call from God and the effort needed to reach a spiritual goal.
